DECLARATION OF LIABILITY

By signing this document, the undersigned declares to assume full responsibility for any damage caused to objects or persons and for the loss of rented equipment during participation in the event "ESNow 2026", organised by Erasmus Student Network Trento (hereinafter "ESN Trento"), which will take place in the Municipality of Folgaria (TN) from 20 to 23 March 2026.

Therefore, the undersigned, being aware of the legal value of this declaration and informed of their obligations, agrees to provide direct and full compensation to the person or entity entitled to any reimbursement for the damage or loss caused. By doing so, the undersigned releases ESN Trento and the Organising Committee from any liability for any damage or loss caused by him/her. Should direct payment of compensation not be immediately possible, the undersigned undertakes to reimburse ESN Trento for any compensation paid to third parties for damage or loss caused by him/her.

Declares:

1. To have understood that participation in ESNNow 2026 is to be considered participation in an associative activity and not a tourist travel contract.
2. To be a member of the association called ESN _____ (Section), to be in possession of a valid ESNcard at least until the end of the event "ESNNow 2026", and to be duly registered for the event ESNNow 2026 taking place from 20 to 23 March 2026.
3. To release ESN Trento and the Organising Committee from any direct or indirect liability arising from my participation in ESNNow 2026, with regard to damage suffered to my own property or injuries caused by third parties. However, should such damage or injuries be caused directly and/or personally by a member of ESN Trento or by a member of the Organising Committee, such liability shall fall personally upon them and not upon ESN Trento or the Organising Committee as a whole.
4. To hold ESN Trento and the Organising Committee harmless from any liability for damage or loss caused by me to property or persons, and to assume the obligation to immediately and personally compensate for such damage or loss or, where this is not materially possible, to reimburse ESN Trento for any amounts paid to third parties as compensation for damage or loss caused by me.
5. To indemnify ESN Trento and consequently compensate the ski and snowboard rental provider in the event of damage to or loss of the equipment supplied by said rental provider, as indicated by the Organising Committee, for use on ski slopes, and to return such equipment to the rental provider indicated by the Organising Committee at the end of its use.
6. Not to damage, in any way or form, entities, persons, tangible and/or intangible assets that collaborate with ESN Trento and operate within the scope of the Event under the supervision or direction of the Organising Committee, undertaking to respect their integrity and rights at all times.
7. To indemnify ESN Trento from any liability and, consequently, to compensate the subjects referred to in point 6 in the event of damage caused to them, their facilities and/or equipment, for an amount corresponding to the value of the damage, as determined through a joint assessment carried out by the Organising Committee and the duly authorised representatives of the parties concerned.
8. To be aware that certain members of ESN Trento, referred to as the "Organising Committee" or "Organising Committee (OC)", will carry out coordination activities for participants free of charge, solely for the purpose of ensuring greater efficiency during transfers, proposed activities and the distribution of informational material, without thereby assuming any responsibility for issues relating to travel, accommodation or any other inconvenience that may arise during ESNNow 2026.
9. To be aware that, in the event of non-compliance with the Internal Regulations of ESN Italy, the Code of Conduct of ESN Italy, the Regulations of ESN Trento, and the regulations governing the use and services of accommodation facilities and means of transport provided during ESNNow 2026, as well as applicable laws relating to safety and public order, the Organising Committee and/or the Board of Directors of ESN Trento reserve the right to take disciplinary measures and/or expel the participant from ESNNow 2026, with immediate removal from all related activities and facilities, without any right to claim a refund, even partial, of the

participation fee paid. Non-compliance with the above-mentioned regulations releases ESN Trento and the Organising Committee from any form of liability towards the undersigned.

10. To grant ESN Trento, the members of ESN Trento and/or third parties authorised by ESN Trento or the Organising Committee full authorisation to photograph, film or otherwise record me (including photos, video footage, TV, radio, video recordings and other known or unknown communication tools), regardless of who carries out such recordings, and to use and disseminate them in any manner deemed appropriate, with full discretion, without requesting any reimbursement or compensation of any kind, and without having any claim regarding the use of such material.
11. To have carefully read and evaluated the content of this document and to have clearly understood its meaning at the time of signing.
12. To acknowledge and accept that, in the event of a dispute, exclusive jurisdiction shall lie with the Court of Trento.
13. That the data and declarations provided above correspond to true, accurate and complete information. I further declare that I release ESN Trento and the Organising Committee from any responsibility directly and/or indirectly connected to such information in the event of inaccurate data and/or declarations or omissions relating to the data provided.
14. To release ESN Trento and the Organising Committee from any liability regarding the content of the data provided and the statements contained herein, which constitute expressions of data and documents approved and confirmed by the undersigned.
15. To be aware of the criminal penalties applicable in the event of false declarations, confirming the truthfulness and correctness of the data provided above, and to undertake, in the event of disputes, to promptly communicate to the Organising Committee any changes thereto.

For the purposes of Articles 1341 and 1342 of the Italian Civil Code:

“The general contractual conditions prepared by one of the contracting parties are binding upon the other party if, at the time of the conclusion of the contract, the latter was aware of them or should have been aware of them by exercising ordinary diligence. In any case, such conditions shall have no effect unless they are specifically approved in writing when they provide, in favour of the party who prepared them, limitations of liability (Article 1229), the right to withdraw from the contract (Article 1373) or to suspend its performance (Article 1461), or impose upon the other contracting party forfeitures (Article 2965), limitations on the right to raise objections (Article 1462), restrictions on contractual freedom in relations with third parties (Articles 1379, 1566, 2596), tacit extension or

renewal of the contract (Articles 1597, 1899), arbitration clauses (Code of Civil Procedure, Article 808), or derogations (Article 1370; Code of Civil Procedure, Articles 6, 28, 29, 30, 413) from the jurisdiction of the judicial authority.”

“In contracts concluded through the signing of standard forms or templates (Article 1370), prepared to regulate specific contractual relationships uniformly, any clauses added to the form or template shall prevail over those contained therein if they are incompatible, even if the latter have not been deleted. The provisions of the second paragraph of the preceding article shall also apply.”
